Thank you to the 16 people who attended the Suffolk County SENY Assembly, 1/25. 75th Anniversary edition of the Big Book Spanish translation was discussed. This issue went to the Assembly, where 89 voting members were in attendance. 76 voted yes on a Spanish translation; 13 voted no. The issue will now go to the AA Board.

Delegate's Day of Sharing will be held March 15, from 9 AM - 3 PM, at 337 E. 74th Street, NY, NY 10021. Light refreshments & lunch will be served. The event is an opportunity for GSRs to go over the Delegate's Questionnaire (DQ) and to learn about background info on each issue.
